# Irish Context

### 129,000 farmers

- Pre-dominantly grass-based (circa 7% arable/tillage area)
- Livestock pre-dominantly outdoor systems
- Livestock profile climate change mitigation challenges
- Twin threats from both agricultural intensification (dairy, etc) and extensification/abandonment
- Water quality
- Biodiversity: semi-natural areas, etc
- Economic Viability / Generational Renewal

### **Economic Sustainability – BISS and CRISS**

- Partial convergence model for Payment Entitlements (PE).
- Capping/reduction of payments over €60,000 by 85% and over €100,000 by 100%.
  - => an effective cap of  $\in 66,000$
- CRISS : €119 m per annum or 10% of total annual Pillar 1 budget
  - $=> \sim \in 40/ha$  on first 30 eligible ha.

## 1. Enhanced conditionality

#### GAECs

- 1: Maintenance of permanent grassland based on a ratio of national reference levels
- 2: Protection of wetland and peatland
- Ban on burning arable stubble 3:
- 4: Establishment of buffer strips along watercourses
- 5: Tillage management, reducing the risk of soil degradation and erosion, including consideration of the slope gradient
- 6: Minimum soil cover to avoid bare soils in period(s) that are most sensitive
- 7: Crop rotation / Diversification in arable land
- (i) Min share of <u>agricultural area / arable land devoted to non-productive areas and features, and (ii) on all</u> 8: retention of landscape features, (iii) ban on cutting hedges and trees during the bird agricultural area, breeding and rearing season (iv) measures for the control of invasive plant species
- 9: Ban on converting or ploughing permanent grassland designated as environmentally-sensitive permanent grassland in Natura 2000 sites





### **Eco-Scheme**

- Budget €1.4bn or €297m per annum (Pillar 1).
- Voluntary for farmers expected participation rate of over 90%
- Range of agricultural practices available participants must select 2 practices, or one "enhanced" option.
- Payment is per eligible hectare independent of entitlements. Payment rate depends on uptake – likely to be approx. €70 per hectare per year for two completed practices.









### **Eco-Scheme Options**

- 1. Space for Nature.\*
- 2. Extensive Livestock Production.\*
- 3. Limiting Chemical Nitrogen Usage.
- 4. Planting of Native Trees/Hedgerows.\*
- 5. Use of a GPS controlled fertiliser spreader/sprayer.
- 6. Soil sampling and appropriate liming.
- 7. Planting of a Break Crop.
- 8. Planting of a Multi-Species Sward.

### ACRES – new delivery framework

- €1.5bn agri-environment climate measure with
  (i) general measure/actions
  (ii) Co-operation measure
- targeted in 8 high-priority geographic areas
  + additional bespoke farm/landscape measures
  + local co-operation team
- Actions for both extensive & intensive farms
- Using hybrid quality-based payment system

## **Organic Farming Scheme**

- Ambitious target to more than triple agricultural area in organics to 7.5% from base of 2%
- Budget of €256m: 5–fold increase in funding
- Target all sectors dairy, livestock, tillage, horticulture
- Reduction in chemical nitrogen, stocking densities
- Contribute 0.3MT reduction of emissions

### **AKIS: Agricultural Knowledge and Innovation Systems**

- Knowledge Transfer intervention, allowing farmers to form groups to look at relevant themes to share knowledge and gain skills.
- Dedicated mandatory training courses for ACRES and Suckler Carbon Efficiency Programme with a focus on getting the best results from the schemes, explaining the actions and focusing also on farm safety.
- Support for mandatory training for advisors.
- Calls for European Innovation Partnerships (EIPs) across a variety of themes.
- A national CAP Network will communicate the CSP to farmers and rural communities and engage with the European CAP Network.





### **Amendment Process**

- 1. We gather and collate input from the divisions implementing interventions on what changes may be necessary based on a variety of factors: e.g. typos, uptake, budget, stakeholder feedback, unforeseen issues, etc.
- 2. We engage early with the Commission through the Geographic Unit in DG AGRI to discuss our proposed changes, and they perform an inter-services informal consultation to ensure there are no legal issues.
- 3. We engage with stakeholders bilaterally and through the Monitoring Committee to present the amendment and seek opinions.
- 4. When a final amendment version has been agreed it is submitted through the Commission's platform for CSP management, SFC2021.
